PRESENTATION Jamie Wagner, Honoring Kathy Wagner

My mother, My Rock, My world. My mother was more than just a mother, she was my best friend, my cheerleader, my inspiration, my advisor, and my travel partner. My mother was superwoman, and I am the luckiest girl to have been her daughter.

I am pushing for the park to be named in her honor as "Kathy Wagner Park", this is a muchdeserved honor for someone who dedicated her life to improving the lives of the children in the community. She wanted the ideals of good sportsmanship, honesty, courage, and respect for authority be engrained in the children so that they will be well-adjusted, strong, and happy children who will grow to be good, decent, and trustworthy citizens of Beaumont. She believed that molding our youth with these ideals was the most important contribution that she could make to her community.

My mom made sure no child was left without, she made sure everyone had equal chance and made sure everyone was able to play baseball/softball at our local community park.

Mom and dad moved to Cherry Valley in 1979 with my 2 brothers and while she was pregnant with me. She started her Tax business and started her 40-year relationships with several of her clients.

Mom had a passion for being involved in everything my brothers and I were involved in, she was very hands on and wanted to be the one who was there for the kids that needed the extra support.

Mom joined the Little League board in 1980 when it was just getting started. She joined knowing that she would do all she could to make sure it would be an amazing program and serve as a great opportunity to provide a safe environment for the kids in the community. Mom was the player agent the majority of her term, but she ended as the treasurer of the league. She also served on the Pony International Board on the Corporate Committee.

Mom would have the board meetings & hold the team drafts at our house for about 10 years at the beginning of the baseball program. Whenever there was conflict at the meetings, my mother would always jump in and resolve the issues. Nobody ever second guessed her thoughts or opinions; she was the most non-judgmental person there could be and gave unbiased decisions every time.

Mom was an accountant and had her tax office on Beaumont Avenue. Her office was the main drop off for player and coach applications, payments for playing in the league, and complaint letters. Board meetings were held at her office and the office address was used as the main headquarters for the league for over 10 years.

My family spent nearly every night at the park, mom made sure the park ran smoothly and made sure all the kids were picked up and taken home safely every night. If kids were still there at the end of the night, we would take them home if they needed a ride. Mom was fully dedicated to that park and the children of our community.

Mom made sure every child had an opportunity to play in the league, with or without money. Mom would have them work off the fees or find other resources so they could play. The park was always well taken care of, she would give trash bags to the kids that were hungry and would give them a specific area to clean up and told them to come back after their bag was full and they could have a free dinner and a candy.

My mother was known by most as Mrs. Baseball because she was everyone's go to for everything, from playing baseball to counseling the children or parents that needed a little extra support.

Mom was a big part of creating the softball program and she made it possible for my softball team to go the Softball Nationals in Virginia. Mom made all the plans and we raised money for the entire team by having car washes every weekend for 2 months. She did the shopping for the snacks for our games and late-night snacks. The memories from this trip were priceless, it was a trip that most of the girls from our team would never be able to have done without the coordination from the coaches and my mother's passion to make it happen.

Outside of the Baseball/Softball program at the park, moms' other passions included Soroptimist International, Boy Scouts as a Pack Leader, Rocking Babies at Glen View HS, AYSO, School Fieldtrip Chaperone, HS Tennis & Soccer Mom, and Beaumont HS Booster Club Volunteer. She served on the Council at Mt. View Jr. High, City of Beaumont volunteer, Fundraising at Our Schools, Cherry Festival Committee, Beaumont Chamber of Commerce, She also was one of the Founders of Cherry Valley Bowhunters 40 years ago. She was always willing to volunteer her time and money toward that would help in the growth and success of our community.

Mom has been honored on several occasions for her passion for Community Involvement and dedication. She has received Citizen of the Year, Woman of Distinction, The Heritage Award, Mother of the Year, Soroptomist Lady of the Month on numerous Occasions, Several honors & Proclamations received from the city of Beaumont as Well as the County & Board of Supervisors. She has received countless honors in working as an accountant, Mom was ranked as one of the Top Tax preparers for over 30 years and built a clientele that far surpassed most accountants. No matter what Mom did, she took great pride in and was a success and excelled in.

MY MOM ROCKED and did not do anything halfway, there is more but there are not enough pages, this is the reason the league has grown to what it has now become and supports thousands of kids in our community.

TO WHOM THIS MAY CONCERN:

I was asked to write a letter about my longtime friend Kathy Wagner and her contributions to the pass area. My first memory of Kathy was meeting her at Cub Scouts. She was a pack leader and my oldest son (then 6 years old) was in her group. She was involved in scouting activities for many years. She persuaded me to be her assistant and that would be my status from that date on in our 40-year friendship. Kathy always gave her time, money and resources toward good causes and especially for children. Our oldest son played his first year of T-ball in Beaumont and in the second year there was a discussion taking place that because of mis-management by the former board there might not be another season of "Little League" for the children. Several people in the area came forward and raised money so the youth in the Beaumont-Cherry Valley area could have a baseball season with "Little League Baseball" and as I recall Kathy was in that group. She was a big part in organizing, raising money, finding sponsors, and recruiting people to serve as board members, coaches, team moms, snack bar and other volunteer positions. She was always involved in any project the league was doing like building the storage building at the park or updating the lights or fields. The league in the 80's and 90's tried to keep the cost to players low, and raise funds needed for equipment, umpires, pictures and insurance through profits from the volunteer snack bar, bat-athon, meet your manager breakfast, and outside sponsors. The children were charged \$25 to \$35 to sign up and if a child's parents couldn't afford to pay, Kathy would sign them up anyway. Many youth players in Beaumont and Cherry Valley were able to play because of Kathy's generosity. She served in many Little League board positions including player agent, uniform officer, treasurer, manager of the "meet your manager breakfast" and served in other positions when others failed to fulfill. Her tax office became the baseball office where you could obtain baseball forms, pictures, or sign your child up for baseball. She was the "GO TO" person for many years for our local baseball league. Her many hours of volunteering continued for many years after all her children were grown and continued until her health stopped her from volunteering. Her family requested upon her death than in leu of flowers for people to make donations to the local baseball league or to the Soroptimist fund for children's Christmas gifts. This was Kathy's wish.

Kathy was also involved in the activities of the Soroptimist Club, including fundraisers, luncheons and buying Christmas gifts and delivering them to needy children. I saw her purchase toys from her own funds' during the year. She also served as Treasurer for the Bow Club and filed taxes pro bono for nonprofit organizations. Her generosity included paying transportation costs for players so they could play out-of-state baseball games, giving large tips to servers in restaurants because they looked like they could use the money. I also witnessed her doing tax returns for people and not charging them because their income was so low, or discounted her fees to others who had other needs. She was a great listener and counselor and would listen to people's problems and try to help if she could. Kathy even volunteered to rock babies for needy people in a Riverside County program. If there was any way she could help children she would give her time. We will miss her and I wish there was more people in the world like Kathy. She does deserve to be recommended for a park dedication for all her hard work and volunteer work she has done for the children and citizens in our community for the last 45 years.

After hours or emergency call-out situations will be charged at time and ½, with a 2 hour minimum per call-out, per man.

Apprentice/laborer personnel working during normal business hours, as previously defined, will be charged at a level of \$40.00 per hour per man.

After hours or emergency call-out situations will be charged at time and $\frac{1}{2}$, with a 2 hour minimum per call-out, per man.

If materials are purchased a 15% markup will be applied to all purchases.

If debris disposal is necessary, a fee of \$150.00 per trip plus the cost of landfill disposal will be charged.

Subject: Weather TRAK Central Command Irrigation System. (Noble Creek Park)

Background and Analysis:

Weather TRAK Central Command is a smart irrigation program controller, which allows an irrigation operator to access and control an irrigation system remotely.

Weather TRAK is a web based irrigation controller wherever cellular service or internet access is available.

Staff had a demonstration Weather TRAK timer installed at Bogart Regional Park in the Day Use Area, this irrigation controller has been in operation since April 15th, 2020.

Consequently, the Weather TRAK program has proven to be an excellent addition for staff to control irrigation sequences such as evaporation transpiration which controls over or under watering. As a result, the District purchased the demonstration model for Bogart Regional Park.

Currently, Noble Creek Park has eight various irrigation controllers which are labor intense and require manual operation. Staff contacted Site One an irrigation distributer to evaluate Noble Creek irrigation systems and they have provided a single bid to consolidate the eight existing controllers into one Weather TRAK central command.

Some of the main features include:

- Site Management, Smart Irrigation Programming, Customizable Site Map, Budget Monitoring, Compliance Monitoring, Email and Text Alerts, Generate Usage Reports Other Included Items:
 - Professional Installation, Steel structured pedestals with locking latch, Master Valve with Flow Sensor

Recommendations:

Staff recommends that the Board approve, comment, or direct staff on Central Command Irrigation System for Noble Creek Regional Park.
