4 RESOLUTION NO. 72-252

5 AND ORDER DECLARING THE FORMATION OF  
6 BEAUMONT-CHERRY VALLEY RECREATION AND PARK DISTRICT

7 WHEREAS, pursuant to proceedings duly conducted under  
8 the District Reorganization Act, Section 5781.3 of the Public  
9 Resources Code and Section 58000 et seq. of the Government Code  
10 for the formation of a Recreation and Park District, an election  
11 for the formation of the Beaumont-Cherry Valley Recreation and  
12 Park District of the County of Riverside, California and for  
13 the first directors thereof, if formed, was held on June 6, 1972,  
14 after due notice as required by law; and

15 WHEREAS, this Board at its regular meeting subsequent  
16 to the election, which is five or more days after said election,  
17 canvassed the returns of said election, as required by law; and

18 WHEREAS, it appears that the proposition for the forma-  
19 tion of Beaumont-Cherry Valley Recreation and Park District of  
20 Riverside County was duly submitted to the qualified electors  
21 of the proposed District and that at said election, 1625 votes  
22 were cast in favor of the proposition to form said District and  
23 921 were cast against the same; and that the three candidates  
24 receiving the highest votes for first directors and for four-year  
25 terms were: Bernie Flores - 1817 votes; L. R. Daniel - 1764  
26 votes; Oscar J. Leeb - 1755 votes; that the two candidates re-  
27 ceiving the next highest votes for first directors and a two-year  
28 term were: Lloyd Owings - 1446 votes; Donald R. Long - 1217 votes;

BE IT RESOLVED, FOUND, ORDERED AND DETERMINED by the Board of Supervisors of the County of Riverside, State of California, in regular session assembled on June 20, 1972, that:

1. The territory so proposed to be incorporated as a Recreation and Park District is hereby declared formed as Beaumont-Cherry Valley Recreation and Park District, County of Riverside, California, under the provisions of the Recreation and Park District Law, Public Resources Code, pursuant to Government Code Section 58132.

2. The territory comprising said district is situated in the County of Riverside and is described in Exhibit "A," which is attached hereto and made a part hereof.

3. That Bernie Flores, L. R. Daniel, and Oscar J. Leeb are declared elected as the first directors upon formation of the district for four-year terms; and Lloyd Owings and Donald R. Long are declared elected as the first directors upon formation for two-year terms.

4. The Clerk of this Board will make the filings required by Government Code Sections 54900, 54934, 56450, and 58133.

Thence northerly along section lines to the northwest corner of Section 14, said Township and Range, said point being on the northerly boundary of Riverside County;

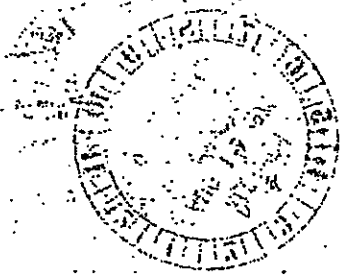
Thence easterly along said northerly boundary of Riverside County to the northwest corner of Section 15, Township 2 South, Range 2 West, S.B.B. & M.;

Thence northerly along the westerly line of said Section 15 to the northwest corner thereof, said point being on the northerly boundary of Riverside County;

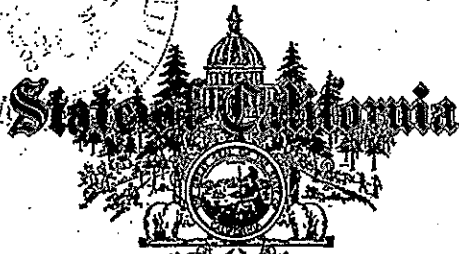
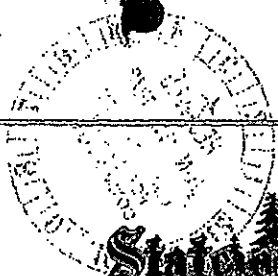
Thence easterly along said northerly boundary of Riverside County to the point of beginning.

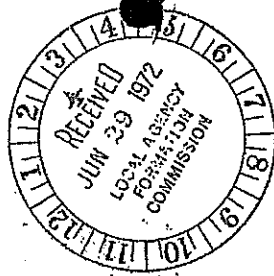
