Activities are in full effect at Noble Creek Regional Park and Bogart Regional Park. Our Staff has remained busy keeping up with the current foot traffic in both parks and we are looking forward to the upcoming projects and events in this month.

- We are preparing for the upcoming Spring Fling and Cinco de Mayo special events.
- Staff tore out and refilled the Quad planters and replaced the material with Palm Springs Gold DG.
- SRS Electric had been going around Noble Creek Regional Park digging up any and all underground
 electrical boxes and securing them with a concrete border backfilled with gravel to help drainage and
 prevent any wires from shorting.
- Staff has continued our Pest Abatement Program and has reduced the numbers of both gophers and squirrels in the landscape.
- I completed and submitted the 1 Quarter Safety Committee Packet 2022 on time to CAPRI.
- The Park District underwent a waterline separation inspection to show that we completely separated the 2 Inch domestic line from the 4 inch irrigation line and passed the test.

- Construction has continued on the new structures being built above the meadow and above the pond in the Bogart Day Use area and staff is assisting in tearing off the roof shingles on the trusses.

BYB host two All Star tournaments, 1 warm up Baseball and 1 "C" district Softball in the month of June annually. There is a parking fee of \$ 5.00 collected from out of town players. Local players, as well as any other facility users are not charged the fee. The \$5.00 fee is only charged for the first two tournaments.

The BYB Facility Coordinator has asked Dodie Carlson, the Athletic Coordinator to request for approval of the Districts board for a parking fee increase to \$10.00 per car for the Pony tournament, for June 23-June 27, 2022 Baseball. This fee increase was suggested by the Pony league themselves because BYB pays the Pony league to host this tournament. The first 2 tournament dates have been previously approved. They are also asking to have this June 23-June 27, 2022 tournament added to the schedule.

BYB is still trying to recover from Covid-19 shut downs. BYB has not been able to generate any monies as there have been no tournaments, therefore no snack bars.

Fiscal Impact:

Revenues from parking fees will be determined based upon monies collected from parking fees and BYB board approval of funds distributed to Beaumont-Cherry Valley Recreation & Park Improvement Corporations Fair Share Cost.

Recommendations:

Staff recommends approving the \$ 5.00 parking fee for June 1-5, 2022 20th Annual Warm up tournament and the June 17-19, 2022 USA 'C" Softball tournament.

I hope everyone is adjusting to the rising temperatures. Staff has been doing a great job keeping up with the current work load and they have been doing an amazing job assisting in the District's current projects. Here are a few items the Maintenance Department has been working on:

Work Items:

- Staff fertilized all the baseball fields and the Day Use Meadow up in Bogart Park.
- Arbor Day was a hit with 15 locally donated trees and 10 donated by the District with a total of 25 trees. All of the trees were planted in the Bogart Day Use Meadow and a new circuit was also installed to help water the trees surrounding the playground.
