5. ACTION ITEMS/BIDS & PUBLIC HEARING/REQUESTS (Includes Committee Reports):

5.1 Approval of State of the City Sponsorship for \$3,000.

Mickey explained that we have a proposal to sponsor the annual State of the City dinner for the City of Beaumont. He reminded the Board that the City has agreed to contribute \$100,000 in reimbursement funds for the Cherry Festival and that they will be joining us for our Foundation Golf Tournament on September 13th, our relationship with them is improving. We are awaiting about \$7,500 in funds for the grease trap that was installed earlier this year at the Noble Creek Snack Bar so it seems appropriate for us to support their endeavors. His recommendation was that the Board approve a \$3,000 contribution for the State of the City event. Approving this amount will keep the current account balance above \$50,000 threshold.

Discussion:

Director Hughes asked if we still have outstanding money from the Cherry Festival. GM Valdivia explained that we are close to submitting all our warrants and we don't see that being a problem. Vice-Chair/Secretary Ward asked if we have a set date for reimbursement, the answer was no. She asked how much they the Gold Sponsorship is for the golf tournament; they did \$1,500 to participate for the first time. She clarified that we haven't received money for the Cherry Festival, grease trap, or a sponsorship, which Mr. Valdivia confirmed and added that he doesn't anticipate any delays on the \$7,500. Deidre Chatigny, Clerk of the Board added that we are returning all of the paperwork, there has been some turnover at the City and we are working with our third contact there to get it taken care of. As for the Cherry Festival, we received the final contractor's bill this week and will be submitting receipts for the \$100,000 once all bills have been paid. Mr. Valdivia said that these are reminders of our growing relationship with the City and he is not suggesting that we have the money before we consider a sponsorship, they are not mutually exclusive. Director Linnemann asked if we have enough people who will show up to fill 10 seats. He said we had a full table last year and we were scrambling to find people. GM Valdivia said that it is contingent on the Board members, we have staff who can fill the seats and it is beneficial for them to network but he doesn't foresee it being an issue, he cannot commit for other people. Director Linnemann suggested that we need to have a better commitment if we're going to commit for a full table and sponsorship, we should have a commitment to get the table filled. Nancy Law added that we also have 2 free seats so in total if the board approves the \$3,000, we will have 12 seats. So far, only 3 Board members have responded that they would be available and interested. General Manager Valdivia stated that he believes the contribution is something that is of value to the city and he has other big projects on the horizon and he thinks it would be a good gesture between us and a major partner.

5.2 Approval of Registration for Autumn Elegance Event

General Manager Valdivia explained that this event is one that we attend annually as part of an ongoing relationship with Valley-Wide, another special district that was formed on the same day as ours. This is one that he inherited from the previous administration and he thinks we should continue to participate. It costs \$60 per seat, purchased individually. Staff can report back and let the Board know how many tickets we get, we can do a Google poll to see how many are interested. It falls below the \$1,500 threshold so there is no action needed today.

5.3 Approval to Sponsor Banning Chamber Luncheon Sponsorship

Director Hughes suggested that we take a Google poll to determine who would like to participate, Mr. Valdivia has the authority to approve up to \$1,500 so we can go from there. GM Valdivia clarified that we were asked by the Executive Director in Banning to sponsor the Chad Bianco luncheon. He said the Foundation has to be careful at spending money in areas outside the District, there needs to be a fine balance. If it was a Beaumont Chamber breakfast or Calimesa Chamber event, he could see a nexus, he doesn't want our region to think that we raise money to give to other events and don't support our own. At a minimum, he suggested getting as many of our people into the room as possible to hear Mr. Bianco speak. Nancy Law, Executive Assistant, added that our balance is \$55,000 and we have already committed \$3,000 today so please consider that.

Vice-Chair/Secretary Ward said that she thinks it's a great idea, she would love to see him in person. However, she wants to be mindful of the \$50,000 limit. In what period of time do we have to stay above the \$50,000. Mr. Valdivia said that we should not, at any time, consider an amount that would allow it to drop below \$50,000, regardless of predicted monies coming in.

Deidre Chatigny, Clerk of the Board added the three sponsorship levels, \$500 for 2 seats, \$800 for 6 seats, and \$1,500 for 8, or individual seats are \$85. Noah Valdivia, Athletic Facilities Manager, added that the Banning Chamber added a foursome to our golf tournament, a \$700 value.

Director Flores is on the line, he has been present but on mute.

6. DEPARTMENT REPORTS:

6.1. Athletic Facilities Manager: Noah Valdivia

Noah Valdivia presented on behalf of the Foundation to give updates on the golf tournament. The event will take place on the Champions course, we only have 8 remaining spots open at this time, he fully anticipates that we will fill up and we are ahead of the game. We are still accepting raffle donations, tee sign sponsorships, those ones usually do pretty well at \$250 per sign. We are doing a putting contest with ducks, trying to get creative, we have all the food and drinks donated and everything for the player appreciation bags. The final Ad Hoc meeting is August 15th. We have 36 bricks currently on order and are waiting for another 10-15 to complete that order and start on the 4th bay at Bogart Park.

Staff gathered for National Pickleball Day on August 8th and members of the public as well as BCVRPD staff participated and had a great time. Nick Hughes and Noah Valdivia cooked and sold tacos at the Avila Horseshoe Memorial Tournament. He plans to get a Foundation banner made so that the Foundation can get recognition at events and people can ask questions while we're serving the public.

Finally, BCVRPD staff will be selling beer on behalf of the Foundation at the Boots, Brews and BBQ event, as well as Oktoberfest. The West Side Ringers are going to host two Foundation horseshoe tournaments this year, the Friday of Boots, Brews and BBQ and the Saturday of Oktoberfest. All proceeds go back to the Foundation.

6.2. General Manager: Mickey Valdivia

Quick election update from Mr. Valdivia: the incumbent for the short-term seat did not pull papers so the nomination period was extended to August 14th at 5:00. The four candidates for the single seat are Janet Covington, Tammy Reyes Letulle, Sally Goodman June and Matthew Shannon. The seat will be for a short two-year term and then it will be back on cycle and up for election in 2026, returning to a four-year term after that. For the long-term seat, one incumbent, Mrs. Ward, did not file her papers so the deadline was extended to August 14th at 5:00pm as well. Initially there were six candidates who pulled papers and four filed before the meeting today. The candidates include Dan Hughes, Rich Lawhead, Christian Linnemann, and John Flores. There was another gentleman who Mr. Valdivia spoke to just before the meeting named Steve Matthews, a citizen of Cherry Valley, who said he filed his paperwork today. There may be a total of five running for three open seats, however he cannot confirm that Mr. Matthews is qualified, that is up to the Registrar of Voters. Stay tuned as the updates typically come every night between 5:00 and 10:00pm. There is a new County Registrar and until he hears that the list is official from them via email or in writing, he does not consider it all the way done. He has noticed some glitches and it is a very difficult job, especially in a year where there is a presidential election. Mickey thanked Noah for his updates and complimented his work with his team and committee on the upcoming golf tournament. He said that we received a letter from Morongo and they are unable to underwrite the green fees but are generously donating several gift baskets that include rounds of golf, a 1-night stay at the resort, and different items which certainly have some value. We planned financially where we

would have flexibility to be more or less generous with the player packages based on their decision. We will scale back a bit in light of the new information. Director Hughes and Mr. Valdivia are going to challenge everyone on one hole and try to raise as much money as they can.

Chairman Diercks: Would like to echo what was said about the staff, everyone is doing a great job, with very little we do a lot, and it’s fantastic. Wish Vice-Chair/Secretary Ward a happy belated birthday.

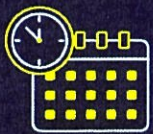

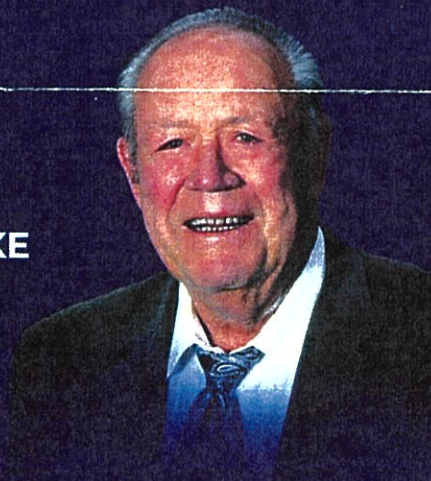

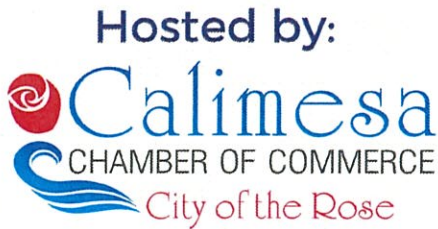
